MINUTES				

The meeting was held at the IHL Building in Jackson, MS. Bettye Graves called the meeting to order. Although she could not be present, Edith Riley was introduced as the new technical representative from MSU.

Minutes

Copies of the minutes were handed out and after a motion to approve by Cay Lollar and a second by Mike Herndon, they were approved.

Financial Report

- Copies of the financial report were handed out. Our balance as of 5/10/2007 is 7,927.57. The only outstanding balance is about \$250.00 for our tax return.
- Becky reported that all dues for the year have been paid except for ASU and they are checking to see why theirs has not been paid.
- We will have tax exempt status for the 2007 MBUG Conference. We have a letter from the IRS to verify our tax exempt status. Becky will give Debbie a copy of this letter to use for ordering supplies, etc.
- Becky recommends that we try to spend most of our money this year to lower our balance.
- Mike Herndon made the motion to accept the financial report and Chris Giger seconded it.

MBUG 2007 Grand Casino, Tunica, MS September 23-25, 2007

- John Elliott reported that our rooms for the conference will be \$79.00 for Sunday and Monday nights. He has booked 200 rooms for each night (originally booked 175 rooms for these nights). Saturday night rates for the board of directors will also be \$79.00. He has reserved 25 rooms for this. He urged all board members to get their reservations for Saturday done as soon as possible. The number to call for rooms is 1-800-HARRAHS and our group code is S09MBUG.
- We have a \$13,000 minimum limit that we have to spend (this is down from \$18,000 originally).
- Chris reported that we will have wireless coverage in all of the convention center. The rate is \$150.00/day for unlimited coverage. We will need an authentication code to log on.
- Kevin will contact Howard Computers about setting up email stations. Jackson State University also volunteered several of their laptops if we need them.
- John will check on us bringing projectors/screens in or if we have to use theirs.
- John handed out a list of foods available.
