MINUTES

Kevin Baker, President, called the meeting to order. We had 21 members present.

The serving of alcohol was discussed. We made the decision to not serve alcohol for the Get Acquainted Social tonight because of a tight budget. We decided to not go over \$2500 on alcohol on the Monday night social. We also discussed what our legal obligations are when we do serve it. This will need to be checked into before next year.

MBUG 2009

It has been discussed that we move our meeting back to spring if we go to the south part of the state next year (because of hurricane season). Donna Hayden is going to check on Natchez. They have a conference center and have just built a new hotel close by. We would need to check out the conference center's policy for hurricane evacuation. It was also suggested that if we stay with the fall that we move to later in September or even into October.

Kevin recommends that we try to build a cushion of \$10,000-15,000 to begin the conference on since we were at a disadvantage this year because of low funds.

Recommendations to raise money were: increase yearly institution dues; increase conference fees.

Vendors

The new fee structure seemed to work very well. We almost doubled our money from prior years. We discussed what to do if the vendor shows up but has not paid. We decided to let them stay and mail the check. We would then invoice them.

If we do not get their check, then they would have to pay the back year plus the current year before they can set up again.

We need to make sure there is enough difference in recognition for the different levels.

We need to limit the number of presentations per vendor. (SungardHE would have unlimited number). We could possible do this on the level that they buy into. We feel that 70-80% of sessions should be Banner presentations.

Doorprizes

Lisa has bought: GPS TOMTOM, IPOD shuffle, portable dvd player. If funds permit we voted for her to spend about \$200 more on doorprizes.

Our next meeting will be at Whispering Woods Conference Center, Tuesday, Sept. 16, 2008 immediately after the conference for a conference wrapup.
