Eric Atchison called the meeting to order.

There were 22 board members in attendance as well as Edith Riley, Program Director.

The minutes from August 5, September 13, and September 16 were approved with Cindy Hampton moving to accept and Louise Brown seconding the motion.

Finances

There were \$7250 vendor fees collected from the conference. The ending balance was \$46,643.20 as of 11/16/2014.

Conference Evaluation

There were 61 evaluations submitted. The following are some comments from the evaluation:

Opening session should have a speaker,

Temperature of rooms was too cold,

Cay Lollar and Ashley Hunter had good sessions,

Need vegetarian options and healthier snacks,

Need AR birds of a feather.

A suggestion was made that we have a boot camp for each module and that a board member or someone from each institution should present.

Vendor Contracts need to be clear and concise. Do we want certain levels to be able to present? (Tabled until next meeting)

Online payments were discussed, but there are not many schools wanting to pay with credit cards. Rosiland will check with MSU, and Stephen will check with PayPal and Square.

Conference Proposals

Louise Brown presented proposals from the IP and Golden Nugget.

IP – Rooms Monday and Tuesday - \$59.99, Saturday - \$149.99; 6 breakout rooms with 5 rooms being \$200 per day; no outside a/v allowed, \$2000 deposit required.

Golden Nugget – Rooms Monday and Tuesday - \$69, Saturday - \$179; breakout rooms \$200 each; must spend \$12,000 on food to get above rates.

Tammie Dill presented a proposal from the Tupelo Hilton Garden Inn. Room rates are \$109; 8 breakout rooms; a total of \$14,000 was spent at the last conference in Tupelo; do not know if the convention center will offer a stipend. Whispering Woods has not sent a proposal, but Tammie will contact them.

Ashley Hunter presented a proposal from the MSU Riley Center in Meridian. There is no hotel attached; 10 conference rooms; breakout rooms are \$250 per room per day; large room is \$1000 per day; no agreement with area hotels.

The decision was made to send additional proposal information thru email, and then allow each school to vote thru email.

MBUG Logo

A motion was made by Louise Brown to upgrade the MBUG logo with Justin Chandler seconding the motion. A motion was made by Cindy Hampton to allow Steven West to do some new prototypes with Donna Hayden seconding the motion. All were in favor.

The motion to adjourn was made by Steven West with Jim Pilgrim seconding the motion.
