Artis Smith called the meeting to order. A plaque was presented to Cassandra Atley, past president, in thanks for all of her hard work.

There were 20 board members in attendance as well as Edith Riley.

The minutes from June 28<sup>th</sup>, September 10<sup>th</sup>, and September 12, 2016 were approved with Cay Lollar moving to accept, and Lisa Williams seconding the motion. All were in favor.

**Financial Statement** – The ending balance as of October 31, 2016 was \$44,942.39. A little money was lost on the conference this year due to fewer attendees.

**Program –** Three sessions are booked for next year. Send ideas for sessions to Edith. A suggestion was made to have topic specific birds of a feather.

**Vendors** – There were 7 vendors at the conference and paying \$5,500 in fees. Send Keilani vendor names that may be interested in attending the conference. Scantron and Time Clock Plus are two possible vendors.

**Registration** – The new registration form helped with issues that normally occur. A suggestion was made to include a new attendee check box on the form. There were 160 attendees.

Bags/Give Away – We will only need to order 100 bags for the next conference if we use the same ones as last year.

T-shirts - Everyone liked the t-shirts.

**Door Prizes** – Attendees liked the giving out of prizes throughout the conference. Carmela Staten won the Ellucian Live registration. It was suggested that the budget be increased from \$500 to \$600 for door prizes.

**Presenter Gifts** – Everyone liked the gifts, but Tom Ritter's was not embossed.

**Entertainment – L**arge group of attendees at the reception, and everyone seemed to like the band. It was suggested that we have a karaoke option next year.

**Reception** – The food was good and plentiful except for the chicken.

**Food Drive** – The attendees responded well to the food drive, and the food bank was pleased with the response. The Natchez Soup Kitchen is a possibility for the next conference, and Donna Hayden will check on other options.

**Survey** – The overall rating on the survey was 4.32. Many attendees want the conference to be on the coast. Meridian, Hattiesburg, and The Mill are possible locations for future conferences. Some session suggestions were travel module, student accounts receivable and BOF topic specific. Online registration was also a suggestion, but the credit card cost would be too high.
